

## ACADEMIC OBSTETRICIAN & GYNAECOLOGIST

The Department of Obstetrics & Gynaecology, Division of General Obstetrics & Gynaecology, Queen's University is seeking a qualified obstetrician gynecologist with Minimally Invasive Surgery (MIS) skills for a Geographically Full-Time (GFT) position. Qualified applicants must have an MD (or equivalent), and Royal College of Physicians and Surgeons of Canada specialty training in Obstetrics & Gynaecology. Given the needed involvement and leadership with the Department's Competency Based Medical Education (CBME) program, a Master's in Education is required. Candidates must be eligible for licensure with the College of Physicians and Surgeons of Ontario. Expertise in Sexual Medicine would be considered an asset.

The successful applicant will be expected to contribute to the educational and scholarly activities within the department. Preference will be given to applicants whose CV and letters of reference can attest to the applicant's ability to work in an interdisciplinary and collaborative environment; and to contribute to both the clinical activity of the Division and the academic productivity of the Department.

The Division of General Obstetrics & Gynaecology at Queen's University has eight members, who have busy clinical practices and contribute to the administrative, educational and research activities of the Department. There is a fully accredited and excellent residency training program and all Departmental Members are expected to participate in the undergraduate and postgraduate medical training programs at Queen's University. The clinical program is based at the Kingston Health Sciences Centre, Kingston General Hospital.

Queen's University is located in historic Kingston, on the shores of Lake Ontario with a population of 125,000, and a catchment area of 500,000. The city offers a unique blend of a small urban area lifestyle combined with excellence in education, geography and entertainment.

The University invites applications from all qualified individuals.
